1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

3. Generic

Experience Criteria: The Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for 3 years before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the year. In case of bunch bids, the primary product having highest value should meet this criterion.

4. Generic

Installation, Commissioning, Testing, Configuration, Training (if any - which ever is applicable as per scope of supply) is to be carried out by OEM / OEM Certified resource or OEM authorised Reseller.

5. Scope of Supply

6. Turnover

OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria. In case of bunch bids, the OEM of CATEGORY RELATED TO primary product having highest bid value should meet this criterion.

7. Turnover

Bidder Turn Over Criteria: The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. 8. Service & Support

11. Certificates

The bidder is required to upload, along with the bid, all relevant certificates such as BIS licence, type test certificate, approval certificates and other certificates as prescribed in the Product Specification given in the bid document.

12. Warranty

Warranty period of the supplied products shall be 3 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

13. Warranty

Successful bidder will have to ensure that adequate number of dedicated technical service personals / engineers are designated / deployed for attending to the Service Request in a time bound manner and for

ensuring Timely Servicing / rectification of defects during warranty period, as per Service level agreement indicated in the relevant clause of the bid.

14. Purchase Preference (State)

Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs from the State of Bid Inviting Authority having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry / State of Bid inviting authority. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 20 % of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 50 percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

15. Sample Clause

After award of contract – Successful Bidder shall have to get advance sample approved from buyer before bulk manufacturing / starting bulk supplies. Successful Bidder shall submit

samples for Buyer's approval, within 5 days of award of contract. Buyer shall, as per contract specifications framework, either approve the advance sample or will provide complete list of modification required in the sample within 5 days of receipt of advance sample. Seller shall be required to ensure supply as per approved sample with modifications as communicated by Buyer. If there is delay from buyer side in approval of advance sample – the delivery period shall be refixed without LD for the period of delay in sample approval. In case, the sample is found to have major deviations / not conforming to the Contract specifications, the buyer at its discretion may call for fresh samples for approval before allowing bulk supplies or may terminate the contract after notifying the deviations to the seller. Unless otherwise provided in the contract, all samples required for test shall be supplied by the contractor free of cost. Where under the contract, the contractor is required to submit an advance sample, any expenses incurred by the contractor on or in connection with the production of stores in bulk, before the sample has been approved unconditionally shall be borne by the Seller and he shall not claim any compensation in the event of such sample being found unacceptable by the Buyer / Consignee.

Special Terms and Conditions

- The bidder's eligibility for a tender fee and earnest money deposit (EMD) exemption is to be considered as per Gujarat State Procurement Policy 2024 (https://imd.gujarat.gov.in/Document/2024-3-21_406.pdf), otherwise, the bidder has to pay EMD Rs. 5,100/- (3% of tender value) in the form of a demand draft in favour of "Principal, L. D. College of Engineering, Ahmedabad" as part of the primary qualification.
- 2. The bidder must submit the original physical instrument of the EMD demand draft with an issue date prior to the bid end date via speed post/RPAD, or in person in a sealed envelope labelled with "EMD of Bid No: ****** ****** within 3 working days from the end date of the bid to the below-mentioned address; otherwise, the off er will be treated as non-responsive.

- 4. For EMD exemption of MSEs and Startups in the procurement of reserved items, eligible entities are to submit the required certificate as mentioned in Gujarat State Procurement Policy 2024's point no. 4 (A) (a/b/c/f).
- 5. As per the Gujarat State Procurement Policy 2024, the minimum average annual financial turnov er or actual production of the bidder/during the last three years, ending on 31st March of the pre vious financial year, should be at least twice the bid value. Documentary evidence in the form of certi fied Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Account ant indicating the financial turnover or actual production details for the relevant period shall be uploaded with the bid. In case the date of constitution/incorporation of the bidder is less than 3 years old, the average fin ancial turnover or actual production in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 6. The successful bidder has to submit and get approved the drawing and panel design/diagram (if applicable) within 5 days from the date of the acceptance of the bid from the buyer. The revised drawing and panel desi gn/diagram (if any) should be submitted and approved within 5 days from the first modification submission.
- 7. The quoted rates should include all taxes, loading/unloading of the bid item(s) up to the delivery place **Bloc** k 2, Electrical Engineering Department, L. D. College of Engineering, Opp. Gujarat University, N avrangpura, Ahmedabad 380015, Gujarat), and other charges as may be required.
- 8. Installation, commissioning, testing, configuration, and training (if any whichever is applicable as per the sc ope of supply) are to be carried out by OEM/OEM-certified resource or OEM authorised reseller.
- 9. The comprehensive warranty period of the supplied products shall be a minimum of 3 years from the date of final acceptance of goods or after completion of installation, commissioning & testin g of goods (if included in the scope of supply), at the consignee location. OEM warranty certificates must be submitted by the successful bidder at the time of delivery of the Goods.
- 10. The seller should guarantee the rectification of goods in case of any breakdown during the guarantee period.
- 11. The seller should have a well-established installation, commissioning, training, troubleshooting and maintena nce service group at the consignee location/State (Gujarat) for attending to the after-sales service. Details of service centres near consignee destinations are to be uploaded along with the bid.
- 12. Bidder/OEM must provide a dedicated/toll-free telephone number for service and support.
- 13. After having been notified of the defects/service requirement during the warranty period, the seller has to co mplete the required service/Rectification/maintenance within a 7-days time limit. If the seller fails to complet e service/rectification/maintenance within the defined time limit, a penalty of 0.5% of the Unit Price of the pr oduct shall be charged as a penalty for each week of delay from the seller. The seller can deposit the penalty with the Buyer directly else the Buyer shall have the right to recover all such penalty amount from the Perfor mance Bank Guarantee (PBG). The cumulative penalty cannot exceed more than 10% of the total contract va lue, after which the Buyer shall have the right to get the service/rectification/maintenance done from alterna te sources at the risk and cost of the seller besides forfeiture of PBG. Seller shall be liable to reimburse the c ost of such service/rectification/maintenance to the Buyer.
- 14. The bidder/OEM must have a registered office or functional service centre in Gujarat State and n eed to submit only government-authorized documentary evidence/proof or a duly signed & regis tered Rent Agreement (for rental office) along with the bid. In case of no production of the requi red document(s)/self-authorised/other unauthorised/false document(s), the bid shall be rejected.
- 15. As per the bid conditions, the documents should be scanned and uploaded online on the GEM portal only. The evalidity of the uploaded documents should be active. If any document's validity is over, the bidder will be declared disqualified.
- 16. The successful bidder shall be required to furnish a Performance Bank Guarantee (PBG) equivalent to 5% of the total landed value of the bid/contract (including all taxes, duties and other costs & charges). The perform

ance bank guarantee shall be in the form of a Bank Guarantee issued by RBI scheduled bank in India in the p rescribed format on a non-judicial stamp paper. **The PBG(s) shall remain valid for a period of guarante** e/warranty plus 60 days.

- 17. The PBG shall be submitted sufficiently in advance (within 15 days from the date of the acceptance of the bid) to enable its verification from the issuing bank, before submission of the invoice.
- 18. The release of the performance bank guarantee(s) after the above indicated period shall be subject to satisfa ctory performance of the equipment/items during the warranty period and fulfilment of contractual obligation s, failing which, action for further extension or encashment of PBG, as deemed suitable, shall be taken. The P erformance Bank Guarantee shall be released after the expiry of the warranty period if no claim is pending.
- 19. In cases where the supplier does not submit the PBG in time or as per the prescribed format in line with the b id/contract stipulations, the PBG amount may be deducted from the first bill or in case of insufficient amount, from the subsequent bill(s) of the supplier till the full PBG amount is deducted. This amount shall be refunde d to the supplier upon acceptance of the PBG submitted by them.
- 20. GST shall be applicable on performance bank guarantee forfeiture and will be extra and recovered from suppl iers/bidders.

22. In case of wrong/insufficient/improper information during the technical evaluation leads to the cancellation of the bid. Therefore, the seller must provide correct information with justified/supportive/applicable documentary evidence.
