The letter must also mention that all support and services will be ensured by OEM for successful and effective execution of hardware operations for at least 03 years from the placement of the date of successful installation of hardware in Department.
- 2) **Bidder financial standing:** Thebiddershould not beunder liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking in to this effect with the bid.
- 3) **Turnover Criteria:** Company Turnover should be Minimum Rs. 02 crores per annum for last 3 years. Necessary documentary proof should be uploaded.
- 4) The bidder should have minimum of 5 years of experience. A table to be prepared having columns as Purchaser's Name and Address, order number and date, ordered quantity, order value. The supporting documents to be uploaded along with the bid. For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:
