##### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

##### 2. Buyer Added Bid Specific ATC

#### Additional terms and conditions to be incorporated while GeM tendering.

1) Diesel is to be arranged by the contractor and in that case cost of diesel shall be reimbursed as per actual or as per local area outlet price whichever is less on submission of cash memo/receipt from authorized outlet on monthly basis.

2) The fuel efficiency/mileage of the vehicle will be taken as 12 km/litre.

3) Bid estimate value is hiring charges + gst @18% on hiring charges.

4) Additional performance security shall be applicable if the bid price is below 15% of the Estimate Bid Value. The amount of such additional security shall be the difference between 85% of the Estimate Bid Value and Quoted price.

Such additional performance security shall be furnished by bidder in the form of FDR/BG within 21 days of issuance of contract order by the successful bidder.

Failure to submit such additional performance security within stipulated time shall result into cancellation of the contract with forfeiture of earnest money.

Additionally, the company shall ban such defaulting contractor from participating in future tenders in concerned Subsidiary/CIL HQ for a period of minimum 1 (one) year from the date of issue of such letter. In case of JV/Partnership firm, the banning shall also be applicable to all individual partners of JV/Partnership firms.

Additional performance security may be furnished in the shape of BG or FDR. If additional performance security is provided by the successful bidder in the form of Bank Guarantee, the validity of the Bank Guarantee shall be for a period of two months beyond the period of contract. Successful bidder can also provide the additional performance security in the form of FDR made out or pledged in the name of A/C (Name of the Buyer). The bank should certify on it that the deposit can be withdrawn only on the demand or with the sanction of the pledgee.

100% additional performance security will be released after successful completion of the contract. "

i) **Security Deposit:** Security Deposit shall consist of two parts;

a) Performance Security to be submitted at award of work @ 5% .

b) Retention Money to be recovered from first four running bills.

**Retention Money:-** All running on account bills shall be paid at 95% (Ninety-five percent) of work value. The balance 5% shall be treated as retention money (exclusive of GST) and will be second part of security deposit.

The security deposits shall bear no interest.

The retention money (second part of bid security) may be released after completion of work as per time line stipulated for release of performance security on GeM GTC.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process.
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the [General Terms and Conditions/सामान्य नियम और शर्तें](#), conditions stipulated in Bid and [Service Level Agreement](#) specific to this Service as provided in the Marketplace.
