#### 1. Generic

#### 2. Buyer Added Bid Specific ATC

1) The bidders shall be required to submit an undertaking certifying the truthfulness of all the documents submitted / uploaded along with the tender/bid/offer. This shall be mandatory for all the bidders. In case of failure of the bidder to submit the undertaking, their offer shall be summarily rejected. The format for undertaking is enclosed.

2) The Performance Security (ePBG) for the work is required to be submitted @10% of the Final Contract Value instead of 5% as stipulated in ePBG details.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
